6., Administrative check for competitors with MNASZ or other ASN licence:

Administrative checks happen in two phases for entered competitors:

a) On- line check

Documents to be uploaded:

(except for category TR/SBS (cross-country Side-by-Side). Their administrative check is to take place at the Rally Office together with the release of Road Book.)

- ASN licences. Only the non- Hungarian licences (foreign ASN) must be uploaded.
- Driver and co-driver valid driving licences (at least category B) must be shown at the release of Road Book. They do not need to be uploaded. **(In case the co- driver does not have a category B driving licence, he/she must fill in an announcement about not driving the racing car during the rally.)**
- Entry form – the online entry system generates it according to the given data.
- Documents of the entered car (registered as a racing car for racing purposes), valid registration documents belonging to the certain registration number. (Technical examination paper or inspection is not acceptable)
- A valid insurance policy covering the registered number and/or chassis number of the vehicle entered, or a cheque for payment of the guarantee (if the insured vehicle can be clearly identified) or other document proving valid insurance cover for the duration of the race.
- Permission from the owner or operator of the vehicle entered for use in the competition, provided that neither of these is the same as a member of the entered crew.
- The vehicle entered must have a valid MNASZ ATB or FIA Technical Passport. In the RC2-RC5 classes, a passport issued by the ASN of the country where the vehicle is registered is acceptable.
- Lending documents (for Competitors if needed).

Deadline for uploading documents in the on-line system: closing date of entries.

Once uploaded, the administrative staff will start checking the documents, and may issue a request for a deficiency, reject or accept documents.

If the uploaded document is not valid, the entry will be immediately cancelled and the procedure will be initiated in accordance with the relevant points of the MNASZ Code of Ethics.

b) Personal check

After online check, both entered competitors are obliged to be present at the issuing of Road Book where their driving licences (the ones signed in the entry form) must be shown up.

6/b, Administrative check for those NOT having a competitor's licence:

The administrative check for competitors without ASN licence (AMATEUR) will take place in person at the time indicated in the Supplementary Regulations at the same time as the release of the road book (both on 6th and 7th December 2024).

- Driver and co-driver valid driving licences (at least category B). **(In case the co- driver does not have a category B driving licence, he/she must fill in an announcement about not driving the racing car during the rally.)**
- Signed entry form – the online entry system generates it according to the given data.
- Documents of the entered car (registered as a racing car for racing purposes), valid registration documents belonging to the certain registration number. (Technical examination paper or inspection is not acceptable)
- A valid insurance policy covering the registered number and/or chassis number of the vehicle entered, or a cheque for payment of the guarantee (if the insured vehicle can be clearly identified) or other document proving valid insurance cover for the duration of the race.
- Permission from the owner or operator of the vehicle entered for use in the competition, provided that neither of these is the same as a member of the entered crew.
- Valid MNASZ ATB or FIA Technical Passport of entered car (not compulsory only if it has one).

5. Description of insurance:

Compulsory vehicle liability insurance must be paid at the release of Road Book.

Extrem rally insurance is included in the entry fee.

MNASZ Insurance Information – according to regulation on website: www.mnasz.hu (regulations of rally events point 7 chapter 1 2024)

- Service cars do not belong to the participants of the rally even not with SERVICE plates. Liability insurance is therefore not valid on these cars, responsibility must be taken by the operator and driver of the car.
- Organizer do not take any responsibility for the damages of the participants. Competitors take part in the event by own responsibility, however, extreme rally insurance is included in the entry fee.

6. Start numbers and ads:

Organizer places orange start numbers of 25 cm (height) on the rear- side windows of the racing cars. Therefore, names must be placed on the certain windscreens as to have enough place for the start numbers.

Organizer is to place further 6 pieces of ads on the front side doors of the rally car beside or next to the start numbers. Figure of the ads do not exceed 20x35 cm.

Text and content of the ads will be released at the beginning of the administrative check at the Rally Office.

Classification of racing cars:

7. Tires:

Any tires, independent from the manufacturers, is allowed to be used at the rally.

During race, it is prohibited to use racing tires of off- road tires!

To protect the conditions of the surfaces, it is also prohibited to use extreme off- road tires!

It is not allowed to use studded tires or street tires studded neither on civil roads or SSSs.

8. Checks:

ASN licence holders except for cross- country:

Administrative check - online

Competitors with no ASN licence: personally when releasing Road Book

At the technical check must be shown:

- Racing suits: **2 pieces of racing suits (min.8856-1986), fire-resistant underclothes**
- Racing crash helmets: 2 pieces – min. with expired homologization (min. red labels)
- Safety belts: min. with expired homologization – but expired not later than 5 years
- Rollcage according to at least valid Rally3 regulations
- 1 piece of validated fire extinguisher inside the rally car
- Fixed emergency triangle, first aid kit
- SOS/OK board
- Power-cut off switch under operation
- 1 piece of service foil with a minimum size of 3x5 meters
- 1 piece of rubbish bag with a minimum size of 120 liters

- 1 piece of fire extinguisher with a minimum size of 4 kg as part of the service area

At the technical checks only clean, maintained cars are allowed to be presented! In case the technical delegates judge the car not acceptable, they can reject its start permission.

Entering hours:

During the rally, service activities are allowed only in the service park. Location of the service park is to be shown in the Road Book. In these areas, any service activity is allowed. For the rally cars service in and out is by Time Controls. Beside the rally cars and officials' cars only vehicles with '**SERVICE**' plates can enter the area (**max. one per a rally car**).

FIA or ASN priority drivers or competitors with MNASZ Gold licence can enter with 2 service vehicles.

Marshals have the right to check service areas to keep the cleanliness of service park. **Leaving service area, entrant is responsible to collect and remove all rubbish on its site.** For this, each team pays a deposit of HUF 30.000 (incl .VAT) at the release of itinerary, which is to be paid back only if marshals verify in written form the adequate condition. This written verification must be shown at Rally Office during opening hours, afterwards no opportunity is given to get back the deposit. If a service area was used by more teams, more verifications are needed.

At the service area, each team is obliged to use an oil and fuel resistant environment mat with a size of minimum 5x3 m.

MNASZ REGISTERED RALLYE EVENT

Trailer parks:

Trailers can be parked only at the designated area beside the service park. Public areas must not be used during the time of the rally, even not in the surrounding of the scrutineering area. Infringement of such rule is penalised by Stewards up to HUF 100.000. FIA General Rules regulate rules in service park, where the **maximum speed limit is 20km/h**. Team members are obliged to obey these rules as well, entrant is responsible for them.

Team cars are not participants of the rally, even if they have their 'SERVICE' stickers on them, hence liability insurance does not cover any of the damages they cause. Owner or the driver of such cars are responsible for any damage they cause.

Only Service and Auxiliary cars can enter service park (with sticker on right upper corner of the windscreen). Registration number of such cars are to be recorded to entrants and will be checked during their presence in the service park.

Regulations on cars with service stickers:

Only one car with 'SERVICE' plate per rally car is allowed to enter the service park.

In case the vehicle enters the service park without a plate or with invalid plate, entered crew may be fined for HUF 50.000. In case the service car enters the service park out of allowed period of time, entered crew is to be fined for HUF 10.000 by the Stewards.

Regulations on cars with auxiliary stickers:

„Auxiliary” sticker can be bought at the administrative check or at rally office afterwards. A maximum of 2 pieces can be bought per a team for HUF 10.000/piece. Such cars can enter service park but can be parked only at the area of their own team. Infringement of such rules means a fine to entrant up to HUF 300.000.

NO Refuelling Zone sticker is to be issued.

Since during the rally no remote refuel zone is to be placed, no refuelling zone sticker is to be issued.

On Sunday refuelling is allowed only the refuelling zone placed in the service park.

On Saturday refuelling is allowed at the own service area.

Regulations on service park and service activities

In the area of service park and in the designated areas with start numbers, only cars with service, refuel or auxiliary stickers can be at present.

At the service area, each team is obliged to use an oil and fuel resistant environment mat with a size of minimum 5x3 m. Infringement of such rules means a fine to entrant of HUF 100.000.

At the service park it is forbidden to wash cars with flowing water or high pressure water. Only dry technology (wipes) or cleaning spray can be used. Infringement of such rules means a fine to entrant of HUF 100.000. **(During rally, cars MUST be washed at places according to rules in Road Book, staff and fee is rovided by the Organizer).**

Any commercial activity in the service area is forbidden. Vehicles with any commercial or promotional activities can enter service and be present only after signing the written agreement with the organizer. Teams can do commercial activities only in their own area for free.

In public roads near and around the service park, parking is allowed only by obeying the rules of Highway Code.

Service crew must have a minimum of 150-liter rubbish bag to collect and transfer their waste before leaving service area.

At any place where service activity is done a minimum of 5-kg fire extuinguisher must be placed visibly.

Catering is allowed in the service area only for own team.

Any political, religious or obscene declaration on the scenes of the rally, especially in the service park, is forbidden and can be penalized with exclusion.

Any commercial activities in the service area is forbidden. Vehicles with any commercial or promotional activities can enter service and be present only after signing the written agreement with the organizer. Teams can do promotional activities only their own area.

Commercial activities, entering of extra vehicles or using extra service area is allowed after the written agreement with the Organizer.

12. Responsibility is entrants:

Crew belonging tot he competitors (ex.: service park staff) is obliged to obey the rules of the rally and the instructions of the organizing staff suring the time of rally. For their behaviour the entrant is responsible during the time of rally.

13. Appeal:

No protest can be required against timekeeping! Any other protest must be sent in written form to the Clerk Of the Course together with the payment of HUF 100.000.

Fee of appeal:

Reconnaissance is allowed only in one direction according to the Road Book. Stages are not closed roads, hence vehicles from opposite direction must be expected to. Infringement of regulations of reconnaissance is the exclusion from the rally by the Organizer.

Before recce registration has to be done: Filling in registration form (REGISTRATION NUMBER AND PRIVACY STATEMENT- found in Appendix 2) and handing it over latest at the issuing of Road Book. Together with the Road Book. Organizer provides each crew a „Recce” sticker, which must be placed on the upper right side of the front windscreen visibly and keep it there during the whole time of recce. Missing plate means the infringement of recce rules. In case of damage, or change of car, it must be signed and drivers need to ask for a new plate.

During reconnaissance only cars according to point 35 FIA RRVSZ can be used. It is prohibited to use the entered rally car.

Restrictions on recce cars:

- o Serial exhaust pipe system with a maximum noise emission within the limits of Hungarian regulations
- o Safety roll cages are allowed to points 8.1.-8.3.5./Art. 253/ App. J
- o 2 pieces of extra headlights acc. to Highway Code is allowed
- o Intercommunication without helmets is allowed
- o In recce cars only entered driver+1 person can be at present

During recce the followings MUST NOT be used:

- gravel racing tyre
- (during recce is allowed to use :
- four season tyres with sign 'E' and winter tyres,
- tyres with sign 'C' for light trucks,
- All Terrain tyres but only for PickUP vehicles)

Infringement of such rules may be penalised by the Stewards' Committee by up to the withdrawal of start permission and RSB must be informed about it.

Max. fine: HUF 250.000

During recce, maximum speed limit is 65 km/h.

Organizer or his delegate can use speed control device to measure the maximum speed at recce.

15. Prizes:

- Places 1-3 in categories for both members of the crew
- Overall places 1-5 for both members of the crew
- LADA CUP: At Mikulás Rally 2024 for Lada competitors in categories L/9 (together with amateur H/6) and L/10 (together with amateur H7) prizes are to be given for Lada crews in case of at least 8 entered crews

Any other prizes, if may be determined, are to be published until the beginning of the administrative checks in Organizer's Announcement.

16. Further special procedures/ To do in case of accidents

If the accident happened on the place with spectators, the driver is compulsory immediately stop and be sure if anybody was not injured or if anybody get into the risk. If yes, the drivers are compulsory to help. In the case, that any person obtains injury, the SS Chief must be informed and take care about foot marks. The crew may leave the place of the accident only with Police approval. Any infringement of this regulation will be penalized by the Stewards, penalty may go as far as exclusion.

Requirements in the case of accident and safety requirements

- 1) All participants must thoroughly know point 53 of the FIA regional regulations about drivers' safety.
- 2) When a red **“SOS”** sign is displayed, or „OK” is not seen, **the crew must immediately stop to render assistance. The crews are compulsory to help to injured persons.** All other cars must stop, too. Second car must continue after getting necessary information and inform next radio point. Following information must be given at radio or stop station:
 - Start number of involved crew
 - Number of injured drivers or spectators
 - Number of persons trapped in car or outside
 - Place of accident (closest point in road book, junction etc.)
 - Any important information (fire, water, electricity)
 - All competitors stopped in the SS must place their red triangle at least 50 m before where the car is stopped even if the car is clear of the road even if they are not disturbing others.
 - If no help is needed, „OK” sign must be placed as to inform other drivers clearly and in time.
 - If giving up rally for any reasons, organizer or CRO must be informed. Giving up rally, time card must be handed over to a marshall at closest TC within the shortest time.
 - All stopped car must give a free way to ambulance.
- If a car stops in stage by any reasons, an emergency triangle must be placed 50 m prior to the car on the side of the road it stopped.

- Extra itinerary can be bought for HUF 5.000 (plus VAT), which can be bought at the scene of itinerary release.
- In case of wild animals destructing a race car, no responsibility on hunting companies can be set due to relevant laws. (Ptk. **2013 Law V 6:563. §. (2)**).
- **In case of any illegal test or recce (prohibited if the organizer has not contributed to it in a written form) from the time of publication of present regulations will be penalized up to HUF 250.000.**
- All rights reserved in case of any documents of **28th MIKULÁS RALLYE including also shortened or expanded versions.** Without the written approval of Laroco MSC, not a piece of such documents can be published.
- Any commercial, promotional activity at **28th MIKULÁS RALLYE can be carried out only with the written approval of Laroco MSC.**
- Media activities at **28th MIKULÁS RALLYE** are regulated by MNASZ Media Committee and MNASZ Rally Media Group.
- Participation at **28th MIKULÁS RALLYE for any kind of purpose** is the only responsibility of the participants and no legal acts can be demanded on behalf of the Organizer.

Appendix 3 – Installation of safety tracking system (GPS)

Installation and proper use of GPS devices will be checked at TC0 (Service OUT).

a.) GPS unit and parts (installation kit)

GPS unit, velcro fixings, 12V cigarette lighter power wire, SOS panel connecting wire (which ensures 12V power in the rally car and connection of SOS panel to GPS device during the rally).

b.) Installation of speed control device in rally car

Rally cars must be equipped with a 12 V power wire directly connected after the battery switch on the right at column B so as having a 5A fuse.

Installation in the rally car is done by the velcro fixings to the right column B by wiring the cable on SOS panel to GPS device with the 15-leg connection and 12 V power wire.

Installation and proper use of GPS devices will be checked at TC0 (Service OUT) on 8 December 2024, Sunday.



c.) Operation of Safety Emergency Console (SOS panel) and use of GPS device during rally:

SOS panel must be placed in the rally car so as it could be reached by both competitors with fastened seat belts. It is advised to place them between the two seats on the floor or on the top of the cabin inside. In case SOS is needed (help is needed) only the switch under the red cover must be used (click it to other position) and the device starts sending SOS to HQs. SOS can be stopped by closing the red cover.

d.) Returning GPS units and parts

At the end of the rally or when giving up race, competitors must return the GPS units and its parts to the operator of the system at HQs or at the end of the rally at the entrance of Parc Fermé.

e.) Emergency voice signal- 'red flag' signal

To support the real-time functioning of the system, proper mobile system is needed. If it is given, the HQs is able to send emergency signals btw. devices. with voice signal. To make it hearing clear, the siren is to be placed behind the seats on the rollcage at the Scrutineering. Installation is to be done by the servicing company.

The Clerk of the Course is allowed to send a vocal emergency signal, equal to red flag, only if at the same time, red flags are shown on the SS.

It is only an amending signal to drive attention to danger. Independent from the vocal signal, once red flags are shown up in the SS, red flag rules must be obeyed.
